ART.1 – Denomination and Goals

ART.2 – Location and Timetable of the Conference

The conference will take place from 23 to 25 April. 2025 in Albufeira, Portugal. The event time will be from 08.00 to 18.00 for the 23 and 24 April. 2025 and 08:00 to 13:00 for 25 April 2025.

ART.3 – Payment Condition

ART.4 – Admission

The participation in the conference is subject to the acceptance by the organizer.

ART.5 – Setting up and Taking Down

ART.6 – Cancellation policy

1. All cancellations must be given to the Organizing Committee by e-mail at info@setcor.org.
2. For the conference, the following cancellation fees will be applied (unless otherwise indicated on the event's web site):
 - If the written cancellation is received by the organizing Committee before Feb 25, 2025, your payment less 30 % of the chosen package rate will be reimbursed.
 - If the written cancellation is received by the organizing Committee between Feb 26, 2025, and March 24, 2025, 50% of the registration fee will be reimbursed.
 - No reimbursement will be made from March 25, 2025.

ART.7 – Damages to the exhibition space

1. Exhibition space must be returned in the same conditions as before the event.
2. The Organizer is not responsible for the loss or thefts of materials or goods left in the event area.

ART.8 – Security

1. Exhibitors must comply with all security and fire-prevention norms applicable in the conference venue.
2. Exhibitors cannot make use of cylinders or other containers filled with gas of any type, or to keep tanks, heaters or other recipients filled with gas or combustibles for the functioning of machines, except in the case of authorization by the organizer and/or the event venue on case-by-case basis.
